

## **STADIUM RULES**

### **ACCESS RULES**

1. The spectators can enter the stadium with a match ticket issued for their names and identity information, and the accredited persons can enter with a valid accreditation card.
2. Before and during and after the competition, around the stadium and on the route of arrival and departure of the competition, the fans and the goods may be searched by the security officers in accordance with the provisions of the Law No. 2559 dated 4/7/1934 on the search for prevention and authorization.
3. In reference to point 1, the ticket holders and accredited persons will be checked by a security officer. It is mandatory to present an ID or passport if requested by the security officer.
4. At the moment of the entry through the turnstile, spectators should present their match ticket at the reader and face the camera. Prior to the turnstile entry, a detailed body search will be made by the security officer.
5. Outside the stadium, its surroundings, audience roaming areas and tribunes are monitored by security camera (CCTV) system for the purpose of providing security and for detecting violators of Law No. 6222. Therefore, since retrospective determination can be made, the audience should not take any action contrary to the law no 6222.
6. It is recommended that disabled spectators' enter half an hour before the Kick off.
7. It is forbidden to sell merchandise or any other article (including food and beverage) within the stadium perimeter and its surroundings.

### **PROHIBITIONS REGARDING THE COMPETITION**

1. Spectators must watch the match from the seat denoted on their match ticket. It is forbidden for spectators to:
  - a. access areas (e.g. function rooms or VIP and media areas) which are closed to the public or for which access is limited to holders of a specific ticket, accreditation and/or, when relevant, supplementary access device, if the person in question is not entitled to access such areas;
  - b. restrict or loiter in areas open to traffic, footpaths and roadways, entrances and exits to visitor areas and emergency exits;
  - c. enter the pitch or the area around the pitch.
2. According to the Law No. 6222,
  - a. Firearms, even if licensed, and other weapons are prohibited,
  - b. Any items that can cause cutting, crushing, bruising or harm and explosive, flammable, combustible or combustible substances are prohibited.
  - c. alcohol, drugs or other intoxicating or dangerous substances, except substances required on duly evidenced medical grounds are prohibited. Weapons, firearms, knives or sharp objects, cutters, crushers, wounding and piercing objects, backpack of any size and bags not larger than A4 (210 mm x 297 mm); aerosol cans; drugs or stimulants and alcoholic beverages, perfume and deodorant bottles; animals (assistance dogs are allowed); balloons; balls and other inflatable things; camera lens larger than 8 cm; cans, bottles or boxed liquids; commercial audio / video recorders, including tripods; fireworks or missile-like objects, explosives, flammable, flammable or combustible substances; food; illegal substances; laptops; laser lights; pepper gas; noise making devices including air horns, buzzers, bullhorns, lightning, whistling sound, Vuvuzelas, megaphones; All kinds of sticks, baseball bat, golf club, selfie stick; lighters; thermoses; t-shirts or clothing containing coarse language or expressions; It is forbidden to enter with any item that can be deemed to be dangerous, inappropriate or offensive to other fans.
3. General law enforcement officers and municipal police officers are obliged to remove persons who sell, supply, distribute, or distribute equipment or materials that are prohibited from entering the stadium around the sports area.

4. Fans in the stadium or its surrounding are prohibited to act publicly and in a manner that is perceived as insulting by persons who hear or see a particular person, regardless of whether they have targeted or addressed a particular person.
5. It is forbidden to make insults and behaviors in the stadium or its environs that constitute insults by considering the differences of the community, religion, language, race, ethnic origin, gender or sect.
6. The offenses defined in Articles 4 and 5 include carrying out such offences by displaying, carrying or hanging banners
7. It is forbidden to enter the sports grounds in order to monitor sports competitions without a valid ticket or accreditation
8. Ticket holders / persons who have been sanctioned by the TFF for violation of law no. 6222 or sanctioned by the TFF are prohibited from entering the stadium.
9. It is forbidden for spectators to enter in violation of the provisions of Law No. 6222 in order to monitor sports competitions.
10. It is forbidden for spectators to use their own ticket / accreditation card in order to allow someone else to enter the sports competition as a spectator.
11. It is prohibited to produce, sell, offer for sale, transfer, purchase, accept tickets / accreditation cards in order to provide entrance to the match as spectators.
12. It is forbidden for spectators to enter the competition area, dressing rooms, corridors of the rooms and athletes exit tunnels.
13. It is forbidden to commit a crime of intentional injury in the stadium or to destroy and damage any property belonging to the stadium. Sports fields and goods in these fields are in the public domain in terms of damaging the property. In the event that the sports fields and the goods in these fields have been damaged by the crimes covered by the paragraph, the persons who cause harm and the sports club to which they are fans are jointly liable for the damages incurred.
14. It is forbidden to bring larger than 2mx3m banners within the stadium on the day of the competition without the approval of the security authorities.

#### **SEATING RULES**

1. The spectator must occupy the seat allocated to them as indicated on their ticket and use the appropriate access routes.
2. It is forbidden to disrupt the competition by using any substances or article or to enter the pitch area.
3. It is forbidden to stand, wait and sit on the stairs.
4. There is no standing on the seats.
5. It is forbidden to hang down from the top of the stands.
6. It is prohibited to touch any unauthorised electrical device and to enter any location which is signed as a hazardous area or signed with "no entry".

#### **REASONS FOR STADIUM EXPULSION**

1. In the event of a crime found by security officials, the spectators who act in violation of Law No. 6222 can be taken out of the stadium immediately to the nearest Provincial Security Directorate Branch or taken to the "Stadium Waiting Room" arranged according to Law No. 6222.
2. Disruption of the match
3. According to Law No. 6222; Entry into the stadium with prohibited substances, bleachers, torches, fog grenades, sound grenades, committing a crime with gun-cutting-piercing tools, throwing items such as stone-metal-bottle or crime in any place in the stadium, extreme levels of alcohol or people who have been found to be carrying or using illegal substances will be taken out of the stadium and are treated by security officials for committing an unlawful crime.
4. The spectator who insists on sitting in area other than that denoted on the match will be expelled.
5. Persons who do not comply with the above-mentioned access rights and prohibitions are removed from the stadium by security officials and will be subject to action in accordance with Law no 6222.

## STADIUM SPECIFIC REQUIREMENTS

1. From the moment of entry into the stadium until the last departure of the spectators, any injured person shall be taken to the "Spectator First Aid Rooms" located in each tribune section for any first aid intervention; if the situation is urgent, the spectator should be transported from the nearest evacuation gate to the ambulance and transported to the nearest hospital.
2. As a result of any emergency evacuation decision, spectators shall act in accordance with the instructions of the nearest security officers. Depending on where the risk is, if the stadium needs to be evacuated, the spectators in the lower tribunes will enter the pitch area; The spectators in the upper stands will be taken to the outside area by going down the stairs to the evacuation doors.
3. There are fire extinguishers in designated areas.

## PROHIBITED ITEMS

To ensure all guests have a safe and enjoyable visit to stadium, fans are not permitted to bring the following items into the arena:



Any item deemed by management to be dangerous, inappropriate or disruptive to other fans enjoyment of the event.
