2. Data we handle and the purposes

As part of your membership, we handle your personal data (e.g., name, date of birth, contact information, payment details) and data concerning your membership (e.g., start date, ID number, entitlement to discounts, notification preferences) for the purposes of your membership. This includes, for example:

- Benefits to your membership, such as access to club publications, discounts in the fan shop or special conditions for tickets.

We share your data with Eintracht Frankfurt partners, so that you can profit from the advantages of being a member. We have a joint data bank for customers with our Eintracht Frankfurt partners, so we can manage our contacts effectively and, where applicable, showing your advertising tailored to your preferences.

If you are actively taking part in sport in one of our teams, we will also handle certain data relating to your sporting activity and career for the purpose of organising training sessions or matches, registering you with sports associations and, in special cases, assessing the state of your health as well as creating and presenting visual content.

3. Your rights

Under certain conditions, you have the right to request disclosure, correction, deletion and restriction of the data we handle and to data portability. You also have the right to withdraw your consent at any time with future effect or to object to certain ways your data is processed. You also have the right to file a complaint with a regulatory authority about how your data is being handled.
